1. The College has to appoint one Professor and two Associate Professors through duly constituted selection committee as per O.U.norms. **Further, the College has to ensure that the Faculty cadre ratio of 1:2:6 is maintained by appointing one Professor, two Associate Professors and six Lecturers for an intake of (60) students in MCA Course at any time. In case, even after making efforts, Professor Candidate is not available, the College may appoint one more Associate Professor in place of Professor.**
2. The College has to appoint a Director for MCA Course.
3. The College Library has to be strengthened by adding books worth Rs.50,000/-.
4. The College has to obtain IDC Membership for the year 2006-07.
6. The College has to maintain teaching diaries.
7. The College has to procure two server class machines.
8. The College has to obtain the approval of the University for the teachers appointed.
