Based on the approval of the AICTE, permission from the Government of Andhra Pradesh and on the recommendations of the University Inspection Committee, sanction is hereby accorded for grant of extension of Provisional Affiliation to **Nishitha Degree College, Nizamabad** to offer **MCA Course** with an intake of Sixty (60) students only for the academic year 2012-2013. The College has to fulfill the following conditions/deficiencies pointed out by the University Inspection Committee and also general rules of affiliation of Telangana University:-

- 1. Appoint teaching staff @ 1:15 through duly constituted Selection Committee as per TU norms before 30th September, 2012.
- 2. The following land and building requirements to be fulfilled before 31st December, 2012 as per AICTE Norms:
 - 1. Building Requirements:
 - a. Separate, Own Pucca Building with 23775 sq. ft for 60 students.
 - b. Building should be in the name of the Society or Trust and not in the name of any individual. It is to be Owned and not on Lease.
 - 2. Land Requirements:
 - a. The Institution should possess 1.5 Acre of exclusive well demarcated land for the intake of Sixty students.
 - b. Title Deed should be in the name of the Institution / Trust and not in the name of any individual. It is to be Owned and not on Lease.
- 3. Purchase Books worth of Rs.25000/- for the academic year 2012-2013.
- 4. Four National and Two International Journals to be subscribed.
- 5. Qualified Librarian to be appointed.
- 6. Teaching Diaries, Students Attendance Registers, Staff Attendance Registers, Acquitance Registers, Stock Registers and Accession Registers are to be maintained as per norms and are to be signed and stamped by the Governing Body Member during the Governing Body Meeting.
- 7. Governing Body meetings should be conducted for every two months by associating University Representative on the Governing Body.
- 8. All the transactions including payment of salaries to the staff should be made through bank.
- 9. To provide Girls Waiting Room with Toilets.
- 10. To provide potable water to all the students in each floor.
- 11. To arrange electrical lights and fans in each class room and lab.

12. The College should display the College Name Board prominently along with the details of the College Full Address, Phone Numbers, Website, Email-ID and its affiliation status to Telangana University.

13. The college should approach the University 15 days before expiry of the term of the Governing

Body/Selection Committee Members.

14. Every College should have a Website and Email-ID.

15. Teaching Staff information to be uploaded Online in Faculty Management System at College Logins.


